GDPR - Data Subject Access Request Form - Guidance Notes

- 1. Customers requesting access to their personal data are required to complete this prescribed form.
- 2. If the account is held jointly with others, data would only be released if the request is made in joint names by all parties concerned who are all required to sign the declaration on the form.
- 3. Specify clearly on the form what the nature of the personal data request is. The more specific you are and the more information you provide, the quicker we'll be able to respond.
- 4. You are only entitled to personal data we hold about you. We cannot provide:
 - the phone numbers of calls or text messages received
 - the content of text messages or personal phone calls
 - numbers, photos, video clips or text messages stored on their phone
- 5. For 'Reload' customers if the phone is not registered with Gibtelecom we cannot verify your identity and so cannot disclose any information.
- 6. Completed forms must be handed in at Gibtelecom's Customer Services Centre, as it will be necessary for the Company to see proof of identity, such as an ID card or passport in order to progress your request.
